- name and surname of a scientific supervisor (for students, masters, and postgraduates), position, title of organization, city (town), country in Polish/English (or English) are in the top right corner (without contractions);
- title of the theses in Polish/English (or English) is in capital letters, align center.

6. Illustrating material should be used minimally. All the figures are grouped as a single object.

7. References are given at the end of the theses.

8. Papers that do not meet the Conference topic and the requirements as well as the papers that are not submitted timely will not be considered.
